The covered packaging configurations are composed exclusively of the packaging components listed in this Declaration. Variations in the quantity, dimensions or arrangement of those components do not affect the validity of this Declaration, provided that no additional or alternative packaging components are introduced.

5. Declaration of Compliance

They will be assessed and incorporated into this Declaration when they become legally applicable. This Declaration of Conformity is issued in accordance with Articles 15 and 39 of Regulation (EU) 2025/40.

6. Standard and Methods Applied

The conformity assessment of the packaging covered by this Declaration has been performed using the applicable requirements of the PPWR. Compliance has been assessed on the basis of the technical documentation maintained by the Economic Operator, including supplier declarations, material specifications, packaging design specifications and any other relevant technical evidence demonstrating compliance with the applicable regulatory requirements. Where harmonised standards or common specifications are not yet available or applicable, conformity has been assessed using the available technical documentation and supplier information.

7. Validity

This Declaration of Conformity remains valid provided that no modifications are made to the packaging design, material composition, manufacturing process, suppliers of packaging components, intended use, or any other characteristics that may affect compliance with the applicable PPWR requirements.

The Declaration is supported by the corresponding Technical Documentation maintained by the Economic Operator and shall be reviewed and, where necessary, updated whenever changes occur

that could affect the conformity of the packaging or when amendments to the applicable legislation require its revision.

The supporting Technical Documentation shall be retained for the period required by the applicable legislation and made available to the competent authorities upon justified request.
