12.3 If any force majeure occurs in relation to either party which affects or is likely to affect the performance of any of its obligations under this Contract, it shall notify the other party within a reasonable time as to the nature and extent of the circumstances in question and their effect on its ability to perform. The parties shall take all reasonable steps within their powers to continue performance of this Contract following an event of force majeure.

12.4 If the performance by either party of any of its obligations under this Contract is prevented or delayed, or can likely be expected to be prevented or delayed, by force majeure for a continuous period in excess of 30 (thirty) days, the other party shall be entitled to terminate this Contract and any connected orders by giving written notice to the Party affected by the force majeure in which case this Contract shall cease and shall not create any binding obligations between the parties.
